Reviewer A Comments:

The author has answered most of my comments.

However, I'm still not very satisfied with the last one. This manuscript is describing a newly designed biclustering model and applied it to the diabetic microarray data. Unless the authors clearly claim their method can only be applied to microarray data but not RNA-Seq data or single-cell RNA-Seq data, otherwise they should either compare the performance on that two data type or mention it as a pitfall in the discussion part. Two fresh published papers can be the data source: PMID: 31106482 and PMID: 31506348, and it may also strengthen the current results. The robustness of the method should be justified as well.
